


Our Audit Firm in Tokyo has joined the Alliot Group

(*) Sakamoto Ryōma (January 3, 1836 – December 10, 1867) was a Japanese prominent figure, a “revolutionary samurai” in the movement to overthrow the Tokugawa shogunate during the Edo period (1603 - 1868) in Japan. Ryōma was a visionary who dreamt of an independent Japan without feudal trappings. He read about the West and was inspired by the example of the United States where “all men are created equal”. He realized that to compete with an industrially and technologically advanced outside world, the Japanese people needed to modernize.


